JOINTLY DEVELOPED

<u>Sussex Montessori School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

• Sussex Montessori School will host a meeting(s) in the Summer (between June and August or before the next school year begins) for parents to review and modify the current Parent and Family Engagement (PFE) policy and plan.

- Additionally, the school plans to work in conjunction with the parent organization to host a Parent-Education / Open House event which will include a meet and greet with families at the beginning of the school-year. This event will allow the school to unveil the PFE policy and will be coupled with a fun/cocktail event and tour to draw more parents.
- These sessions will be available in-person (when possible) as well as virtually with breakout rooms.

ANNUAL TITLE I MEETING

<u>Sussex Montessori School</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- Sussex Montessori School will host its Annual Title 1 meeting in September or October of each year. The Annual Title 1 meeting may be combined with an Open House, Family Resource Fair (table with community resources and partners), or other Back 2 School event. The meeting will provide an overview of the Title 1 program at SMS, the Montessori curriculum used, and may incorporate a campus tour or display of classroom materials and student's work.
- The Annual Title 1 meeting may be held on SMS campus and/or virtually for parents who cannot attend in-person. The Recorded session will be made available on school website or social media.
- To limit some of the barriers families may face in participating in the meeting, the school may provide an interpreter/translator and make efforts to provide food and childcare.
- While the Annual meeting may likely be held at the school, other parent activities/meetings may be held in the various communities (community centers, other towns) through Sussex County.
- The School will use information from a family survey to identify the best day and time to host this meeting. Parents may receive communications with at minimum three date options for the Annual Title 1 meeting- week night, weekday, and weekend option. The final date will be selected based on responses and official meeting announcements will go out to parents at least 2 weeks prior to the confirmed date.

COMMUNICATIONS

<u>Sussex Montessori School</u> will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, childcare or home visits, as such services relate to parent and family engagement.

- Overall, the school seeks to partner with local youth serving organizations such as the Boys & Girls Club, as well as childcare facilities and mental health services to provide educational outreach to families at least once a quarter.

BUILDING CAPACITY OF PARENTS

<u>Sussex Montessori School</u> will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
 - The challenging State's academic standards
 - The State and local academic assessments including alternate assessments

 - How to work with educators to improve the achievement of their child
- Sussex Montessori School seeks to increase parent involvement and education/understanding of the Montessori curriculum/philosophy and State academic standards through the following ways:
 - ParentCamps the school will host sessions to promote open dialogue, information sharing, meaning communication and connection between families, school staff, and community members. Through opportunity, equity, and access, stakeholders participating in Parent Camp sessions are heard, seen, and valued. As a result, family, community, and school partnerships are strengthened.
 - <u>Welcome Sessions</u>— to welcome and orient newly enrolled families to the Montessori Classroom. (to also include classroom and campus tours)
 - <u>Readiness Fairs</u>— to prepare registered families with important school and classroom information and academic, social-emotional and other community resources before/at the beginning of the school year. Families have the opportunity to meet other families, teachers and staff, and community partners.
 - Open House & Parent Education Materials—provide written materials and Open House events centered around the Montessori Philosophy & Curriculum in efforts to educate parents about the Montessori learning tools classrooms use, state standards and tests/assessments. This will take place early in the school year and may include Child-led Montessori videos of the materials used and their purpose.
 - o <u>"Parents as Students"</u> the school may host fun, educational sessions where parents receive hands-on Montessori lessons by teachers. This activity will help

parents truly understand how different subjects are taught in the Montessori classroom. Some of these lessons may be taught by actual Montessori students (via workstations)

- <u>"Watch Me Work" Days</u> parents may visit as observers during a live classroom setting.
- "<u>Family Visitation Days</u>" parents receive child-led tour of classrooms and display of student's work.
- <u>VIRTUAL Live Cam</u> -parents may watch, virtually, teachers working with students and teaching lessons). This may be coupled with Transparent Classroom app.
- <u>State Assessment Workshops</u> specifically designed to educate parents about the Common Core standards and Smarter Balance State Assessments.
- Fall /Spring Parent-Teacher Conferences opportunities for parents to discuss children's learning/progress, how prepared their child is, and what changes need to happen for them to improve or meet academic proficiencies.
- <u>Up-to-date Communications, Support and Technical Assistance</u> through the use of different apps (i.e. Transparent Classrooms, Zearn, Readworks, Zooms, Emails) to keep parents informed of student's daily/weekly learning, assignments, areas of need/improvement and ways they can help their child grow, prepare for tests, etc.
- <u>Montessori at Home</u>. Available resource for Montessori-related activities parents can do at home with their children. This may include suggestions for additional materials/assignments that parents and students can work on to build their skills/competency.
- Online Parent Portal List of Resources (classroom/learning resources and apps used by teachers/parents).
- <u>Skill-Building & Technical Support</u> Post YouTube Videos, tutorials, webinars or inperson sessions on how to use certain classroom apps (i.e. Zoom 101) for families who may not be proficient in using various technologies.

BUILDING CAPACITY OF SCHOOL STAFF

<u>Sussex Montessori School</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

• Professional Development (Equity) Training and Coaching throughout the year and during the summer months

• When feasible, Sussex Montessori School may consider hiring a Resource Officer (police officer/paid position) to provide extra security and develop safety plan. This will only be done should the need for security in this fashion arise.
