- Sean Steward reviewed the main topics of the Finance meeting held on November 8, 2022.
- Sean Steward presented the financials to date through October 31, 2022
 - October 31, 2022, represents two (4/12) months actual or 33.33% of the current fiscal year.
 - We have received 77.20% of our State and Local budgeted revenues.
 - We have spent 33.67% of our State and Local Expenses.
 - We have spent 36.86% in Federal Grants.
